Board Retreat

The Global Fund Secretariat and Board Leadership held a Board Retreat on 8-9 July 2024 in Geneva to discuss funding sustainability for combating HIV, tuberculosis, and malaria. Representatives from the South East Asia Constituency attended. Key discussions included strategies for the 8th GF Replenishment, sustainable action plans, and policy options. Ms. Aishath Samiya, Alternate Member, emphasized the need for caution in reducing funds for high disease burden countries, prioritizing impactful policies, integrating disease programs into primary healthcare, and supporting regional manufacturing capacity. Decisions on these issues will be finalized at the 52nd Board Meeting in November 2024.

Global Fund Collaborates with Country Public Financial Management Experts to Maximize Impact and Sustain Donor Investments in Health

The Global Fund Secretariat convened Public Financial Management (PFM) meeting on 3-5 July 2024 in Geneva. PFM is part of the solution to enable integration and sustainable health systems strengthening. This approach ensures that resources are efficiently coordinated, managed and used to

achieve impact and improved health outcomes. Representatives from the South East Asia Constituency members, India and Indonesia, and other countries (Benin, Burkina Faso, Cote d'Ivoire, Ethiopia, Guinea, Jamaica, Lesotho, Malawi, the Philippines, Rwanda, the United Republic of Tanzania and The Gambia) participated in the meeting – to bolster country engagement and spearhead acceleration in the PFM maturity journey.

Global Fund Board Extends Term of Executive Director

The Board of the Global Fund to Fight AIDS, Tuberculosis and Malaria (the Global Fund) approved the extension of the term of the Executive Director, Peter Sands, until the end of 2026. The extension will provide continuity of leadership through the Eighth Replenishment and allow for a robust selection process for the next Executive Director. The selection of the next leader is expected in mid-2026, and they are projected to begin their term later that year.

The Executive Director of the Global Fund serves a four-year term, which can be renewed once. Mr. Sands' first term started in March 2018 and was subsequently renewed, with his current term originally scheduled to end in March 2026. Over the years the Board has repeatedly recognized the service and leadership of Mr. Sands to date, through periods of major changes and challenges in global health.

Meeting Audit and Finance Committee Member

Board Member Professor Dante Harbuwono met with Rai Mahimapat Ray, who has served as an AFC committee member since May 2022. Mr Ray shared about his duty in conducting financial oversight and the challenges of being a committee member. His term will end in 2024 and he emphasized that the constituency continues to have representation in the committee (AFC or Strategy Committee/SC) to have the ability to understand and follow the relevant issues prior to attending a board meeting.

UNAIDS Report 2024: AIDS at a Crossroads

UNAIDS launched a new report highlighting significant progress in HIV treatment, with 77% of people living with HIV accessing treatment and a record of 1.3 million new HIV infections and 630,000 AIDS-related deaths in 2023. This report also brings together new data and case studies which demonstrate that the decisions and policy choices taken by world leaders this year will decide the fate of millions of lives and whether the world's deadliest pandemic is overcome. Focus areas include tuberculosis (TB), Chronic Obstructive Pulmonary Disease (COPD), pneumonia, and other lung health challenges.
