26A Ethics and Governance Committee Meeting

On 27-28 January 2025, the Global Fund hosted the 26A Ethics and Governance Committee (EGC) meeting.

This meeting focused on discussing the selection processes for committee leadership and membership, including Audit and Finance Committee, Ethics and Governance Committee, and Strategy Committee. This was a follow-up to the nominations process conducted by constituencies, including South East Asia in November-December 2024.

The EGC will continue reviewing nominations and conducting due diligence, with a final Board Leadership review scheduled for March 2025.

Global Fund News

Global Fund Unveils Pioneering Climate and Health Fund to Accelerate Global Action

On 23 January 2025, the Global Fund launched a new private sector investment opportunity as part of its Eighth Replenishment fundraising effort, aiming to raise US\$2 billion from businesses, philanthropists, and foundations. Announced during the World Economic Forum, this initiative highlights the transformative potential of private sector contributions in the fight against HIV, tuberculosis, and malaria. Investments are projected to generate a 19-to-1 return in health and economic benefits while saving over 2 million lives. The Global Fund's public-private partnership model brings together governments, corporations, and civil society to accelerate progress in global health and pandemic preparedness.

The private sector has played a crucial role in advancing health solutions through lifesaving innovations, including next-generation mosquito nets, long-acting PrEP for HIV prevention, and AI-driven diagnostics. These contributions have improved disease prevention, treatment, and healthcare delivery worldwide. Peter Sands, Executive Director of the Global Fund, emphasized that private sector engagement is essential in scaling up impact, addressing gender and human rights barriers, and strengthening community health systems. The fund is calling on businesses and philanthropists to expand their involvement in scaling innovations and overcoming health inequities.

Private sector partners have historically contributed over US\$5.2 billion to the Global Fund, impacting over 100 countries. The Eighth Replenishment presents a critical opportunity to mobilize additional funding, ensuring continued progress toward ending HIV, TB, and malaria while enhancing global health resilience. By partnering with the Global Fund, private investors can help build stronger, more sustainable health systems and drive global efforts to create a healthier and more equitable world.
